CAT ADOPTION CONTRACT

N.B. Each page must be initialled by the representative of Langebaan Animal Care ("LAC") and the representative of the new adoptive family.

We do ask a lot of questions and that puts a lot of people off but the reason why we ask so many questions is simple, many of these orphans have come from neglected or abused backgrounds.

PLEASE READ CAREFULLY - THIS IS A LEGAL DOCUMENT

Please note: from here on in "LAC" refers to Langebaan Animal Care (NPO 043-772) and "the family" refers to the family adopting the cat/kitten.

If you are adopting a cat that is still too young to be sterilized, the following terms and conditions strictly apply regarding your obligations towards the cat's sterilization:

- 1. Sterilization must take place once the cat/kitten has reached 5-6 months of age.
- 2. Should sterilization not take place on or 15 days after appointment date, LAC retains the right to repossess the cat- additionally, your adoption fee will not be subject to a refund.
- 3. The family is not permitted to take the cat/kitten out of the country until such time that the sterilization has taken place.
- 4. The family is not allowed to re-home the cat/kitten. Should the family be in a position that the family can no longer care for the cat/kitten, the cat/kitten will have to be surrendered back to LAC.
- 5. Should the family relocate in the period before the sterilization LAC is to be notified and the appropriate home checks will be conducted.
- 6. LAC will be financially responsible for the sterilization and only the 1st vaccination, which will be conducted at one of the approved welfare veterinary practices in your area.
- 7. Should the family wish to sterilize the cat/kitten at a private veterinary practice, the adoption fee will not be refunded, and the cost of sterilization will be the responsibility of the family.
- 8. The family will be responsible for all other veterinary care upon delivery of the cat/kitten.
- 9. The family will ensure that kitten vaccinations will be kept up to date as prescribed by the vet.
- 10. LAC ensures within reasonable terms to place a healthy cat/kitten and therefore LAC cannot be held responsible for any illness or disease after handover to the family.

- First vaccination at 8 weeks (Responsibility of LAC, please check vet card for 1st vaccination date)
- Second vaccination at 10–12 weeks (Your responsibility)
- Third vaccination at 14–16 weeks (Your responsibility)
- Annual vaccinations (Your responsibility)
- Rabies vaccination every 3 years (Your responsibility)

Please bear in mind that it can take 6 to 8 weeks for your new addition to settle into your family. It is scary for a cat, whether young or older, to find him/herself in a new home with new people and animals.

Please remember that we are here to help you, even after you have adopted your pet. If you need any help or advice or just want to share pictures and stories, please get in touch. We would love to hear from you.
